Supplement to the Condominium Declaration for Breakaway West:

1. The Real Estate which is the subject matter of this Supplement To Condominium Declaration For Breakaway West is described as follows:

A Parcel of land being a portion of Lot B-3, Block "B", Lion's Ridge Subdivision, according to the plat filed in the office of the Clerk and Recorder of Eagle County, Colorado, being more particularly described as follows:

Beginning at a point of intersection of the northerly right-of-way line of Lion's Ridge Loop A 60.00 foot dedicated road in said Lion's Ridge Subdivision, the southern most corner of said Lot B-3, and a point on the Westerly right-of-way line of U.S. Interstate Highway No. 70; thence N 59°57'06" E along the Westerly right-of-way line of said U.S. Interstate Highway No. 70 and the Easterly boundary of said Lot B-3 a distance of 70.09 feet; Thence N 01°42'11" W a distance of 69.90 feet along said Easterly boundary of said Lot B-3; Thence N 64°41'52" W a distance of 187.78 feet; Thence S 13°06'48" W a distance of 67.09 feet to a point on the Northerly right-of-way line of said Lion Ridge Loop A 60.00 foot dedicated road being a point on a curve; Thence along said Northerly right-of-way line the following two (2) courses:

- (1) 176.32 feet along the arc of a curve to the right having a central angle of 32°50'52", a radius of 307.56 feet and a chord that bears \$ 46°32'29" E 173.92 feet;
