Update on pool renovation:

- 1. Post tensioned tendon condition assessment: analyzing garage structure to make sure of what is put on top, pool, etc. Cost, \$16,000-24,000, additional.
- 2. Optional Service: existing reinforcement and concrete properties testing, \$8,000-12,000 additional.

Scott Payant moved that we agree that the proposal be sent to the Breakaway West attorneys and if there are no issues that Andrew Cuomo be given the authority to spend up to \$36,000 for the proposal. Mark Maglio seconded the motion; the motion passed.

#### TREASURER'S REPORT

Scott Payant reported on the recent financials which are posted on the website.

Scott Payant moved that the audit requirement to have financial statements audited for 2021-2022 be waved. Mark Maglio seconded the motion. The motion passed.
